#### **1.- Validity**

#### **2.- Reservations**

Every hotel reservation made through the online booking system on the web site <http://www.versiliainfo.com> is communicated by email to our office, to the chosen hotel and to your email address.

#### **3.- Booking and payment contract**

After booking, the contract is immediately stipulated between the person who made the reservation and the hotel management. Every right and obligation related to the reservation contract, are only between this two subjects.

The Consorzio of Promozione Turistica of Camaiore, which is owner of the online booking system, is excluded from every noncompliance of the two subjects which have stipulated the contract.

#### **4.- Cancellation and penalty**

Cancellation terms are different for every hotel management, so if you desire cancelling or changing your reservation, please contact the hotel management directly. For every cancellation or modification over the prearranged timelimit, the hotel is allowed to ask the payment of a penalty.

#### **5.- Hotel rates and information**

This classification is based on details provided from the hotel management, and from the Competent Authority; all the information and descriptions about the hotel are details given from the hotel management itself.

## **6.- Room prices**

All the prices are provided from the hotel management and are valid for all the reservation made through the online booking system.

The payment will be done directly to the hotel management.
